## **SAMPLING AND QUALITY ANALYSIS RESULTS:**

The pre-sampling was performed as pre-shipment. A sample was submitted for analysis to laboratory. The following results of analysis have been obtained (Test report No.16540 Be, dated 23.10.2025 of MORSERVICE, SPECIALIZED ORGANIZATION ON ESTIMATION OF TRANSPORT HAZARDS OF CARGOES COMPETENT AUTHORITY OF UKRAINE DESIGNATED BY IMO):

THE SUMMARY SPECIFIC CONCENTRATION OF CAESIUM 134 – IS LESS THAN 1,2 BQ/KG WITH THE PERMISSIVE LEVEL – 100 BQ/KG;

THE SUMMARY SPECIFIC CONCENTRATION OF CAESIUM 137 – IS LESS THAN 5,7 BQ/KG WITH THE PERMISSIVE LEVEL – 100 BQ/KG;

THE SUMMARY SPECIFIC CONCENTRATION OF STRONTIUM 90 - IS LESS THAN 7,7 BQ/KG WITH THE PERMISSIVE LEVEL - 30 BQ/KG.
