SAMPLING AND QUALITY ANALYSIS RESULTS:

The sampling was performed according to the GAFTA 124 rules at the time of loading. A composite sample of the total consignment was proportionally mixed and submitted for analysis in GAFTA accredited reputable and independent laboratories. The following results were obtained:
