RESULTS OF QUALITY INSPECTION

Representative samples of the oil have been drawn from each ship's tanks 1P, 1S, 2P, 2S, 4P, 4S, 5P, 5S, 8P, 8S, 10P, 10S of MT NORMAN and sealed from vessel's tanks after completion of loading according to FOSFA CONTRACT No.54. Vessel's samples were submitted for analysis to FOSFA approved chemical laboratory. The following results of analysis have been obtained:
