

INTERNAL CONDITION OF THE BANANAS

Additionally, the internal condition of the bananas under the peel was assessed. The findings indicated:

Color: Brownish yellow

Texture: soft

Smell: bad smell detected

Condition: rot and mold

These observations confirm that the internal quality of the bananas affected due to temperature breakdown during the voyage and the cargo inside the 2 containers is totally damaged.
