### RESULTS OF WEIGHT INSPECTION

Weight of cargo loaded ex barges directly into ship's holds was determined as per shore scales under CISS GROUP Ukraine LLC superintendent supervision. Discontinuous weigher Type: electronic hopper-type scale #1 (ABS-XL 14 SCS).

Prior to commencement of loading the weighing equipment was reset to zero and all weighing equipment and conveying elements being used were inspected from visibly accessible parts and were found clean and empty.
