RESULTS OF WEIGHT INSPECTION

The total weight of the cargo loaded into ship's holds ex barges Nos. Nibulon Max, NBL 015, NBL 014, UAK 4, UAK 2, NBL 023, NBL 016, UAK 3, NBL 017, NBL 012, NBL 018, NBL 037, NBL 003, NBL 005, NBL 010, NBL 002, NBL 008 was ascertained as per shore scales figures at the time of loading of barges under CISS GROUP Ukraine LLC superintendent supervision. Prior to commencement of the loading the weighing equipment was reset to zero.
