SAMPLING AND QUALITY ANALYSIS RESULTS:

Pre-shipment sampling was performed according to the GAFTA 124 rules before discharging by CISS GROUP Ukraine LLC as a GAFTA approved superintendent. The samples were taken jointly with Control Union in the port Dekheila from the top layer of cargo and submitted for analysis to accredited reputable and independent laboratory. The following results were obtained:
