RESULTS OF QUALITY INSPECTION

Representative samples of the oil have been drawn from each ship's tank 1P/S, 2P/S, 3P/S, 4P/S, 5P/S, 6P/S of MT BESIKTAS ICELAND and sealed from vessel's tanks after completion of loading according to FOSFA CONTRACT No.54. One vessel's sample were submitted for analysis to FOSFA approved chemical laboratory. The following results of analysis have been obtained:
